**The Matching Gift Process**

Matching gifts/volunteer hour grants are generous ways that companies support the monetary and time contributions their employees make to the community through non-profit organizations.

The Matching Gift process must be initiated through the employee/volunteer with their company. The completed Matching Gift form should be returned to the Scout office as soon as possible. The Scout office will match the form with the donor's gift and, as soon as the donor's pledge is paid in full, will submit the form to the company for the matching funds. Units may count Matching Gifts toward unit base and growth goals as soon as the form is submitted to the Scout office, recognizing that it will show on the base goal reports in the Scout Shop only when the form has been submitted to the company. Volunteer hour forms will be processed as they are received.
